Fitness center named in honor of fallen hero

CAMP VICTORY - A newly-built fitness center on Victory Base Complex was dedicated April 10 in honor of Sgt. 1st Class Paul. R. Smith, a man his peers and seniors said demanded perfection.

The Sgt. 1st Class Paul R. Smith Physical Fitness Center serves residents of Camp Victory and other surrounding installations including Camp Liberty.

"It's fitting that we dedicate a fitness center to a man who had high standards, loved Soldiers and loved helping them become better and stronger," said Brig. Gen. William Grimsley, deputy commander of the 4th Infantry Division. At the time of Smith's death, Grimsley was the 1st Brigade Combat Team, 3rd Infantry Division commander.

Staff Sgt. Steven Holloway, a 3rd Infantry Division engineer, former member of Smith's platoon and a personal friend, agreed naming the fitness center after Smith was apt, since Smith constantly pushed his Soldiers to be disciplined, fit and "perfect," he said.

"He was a person who demanded perfection from his Soldiers. When his squad ran infantry battle drills, if they were good, but not perfect, he'd say, 'run it again.'"

On April 4, 2003, Holloway was just 100 yards from Smith at the time Smith was mortally wounded by braving enemy fire and engaging the attacking force, saved the lives of numerous wounded Soldiers.

IA, CF show positive working relationship

FOB DELTA – An Iraqi Police-led operation in An Numaniyah sent a message to criminals in the city - Iraqi Security Forces are in control.

More than 300 IP, Iraqi Army and Coalition forces deployed to An Numaniyah to conduct checkpoint operations in a joint effort April 7. Dubbed Operation Crystal Springs, the mission also provided ISF and Coalition leadership the opportunity to engage with local government officials and sheikhs.

"It was an operation that was planned by the Iraqi Police, supported by the Iraqi Army and the Coalition forces," said Capt. Eric Wigley, commander of the 511th Military Police Company. "The mission was designed as a non-kinetic mission to go out to Numaniyah ... to set up and conduct numerous checkpoints and just to let the people know that the Iraqi Police, the Iraqi Army and the Coalition forces can plan and operate together."

Sgt. Shane McAllister, a team leader with the 511th MP Co., said the mission showed the local populace that ISF are in control of the area and enforcing the rule of law.

More than 300 Iraqi Police, Iraqi Army and Coalition forces deployed to An Numaniyah to conduct checkpoint operations during Operation Crystal Springs.

An Numaniyah has had little Coalition presence in the past. The Wasit Police Chief, Maj. Gen. Abid al Hanneen Faysal Ameer, and the 8th Iraqi Army Division commander identified the city as a security priority, said Wigley.

"They wanted to show the people that they are committed to the city, they are committed to their populace and they can, when they want, mass forces to help secure the population," Wigley said.

The forces established four checkpoints strategically placed in and around the city to interact with residents, search vehicles for contraband and distribute humanitarian assistance

At one checkpoint, the ISF, along with Soldiers from 511th MP Co., from Fort Drum, N.Y., searched more than 200 vehicles. The U.S. forces were there in an advisory role, said 1st Lt. Lynnette Jefferson, a platoon leader with 511th MP Co.

"Our Soldiers knew what was expected of them," she said. "They understood that the checkpoints were an IP responsibility."

Jefferson said the MPs have trained with the IPs on conducting vehicle and personnel searches, conducting joint patrols and reacting to improvised explosive devices, small arms fire and precision gun fire.

Combat Stress Control Reminders

- Some amount of stress is necessary to enhance performance, but too much stress can have the opposite effect.
- Acute Stress intense, brief episodes of work where factors of fear of failure or fear of physical harm are paramount.
 - Loss of concentration.
 - Impaired task performance (making mistakes).
 - Impaired judgment.
- Chronic Stress takes place over long periods of time and can lead to behavioral problems.

- Modulate Stress levels by:
 - Ensuring good general physical fitness with an adequate, moderate diet.
 - Developing a good work/rest cycle to ensure adequate rest.
 - Modifying work conditions to maximize productivity.
 - Developing high levels of confidence and proficiency through realistic training.
 - Staying connected with family and loved ones.

To Our Soldiers and Families

Today, President Bush announced his decision to return to twelve-month deployments in the CENTCOM theater for active Army units. The President's decision reflects the improved security situation in Iraq – one made possible by your unwavering commitment and willingness to sacrifice – as well as the recognition of the impact of extended deployments on Army Families and our readiness. Today's policy change will help reduce that strain as we continue to grow the Army and restore balance.

The Army will reduce "Boots On the Ground" time to no more than twelve months for all active component Soldiers deploying to the CENTCOM area of operations after 1 August 2008. Soldiers deploying prior to 1 August will complete their scheduled deployments.

The return to twelve-month deployments does not change the Army's dwell time policy. This policy is intended to give units time to properly reset and allow Soldiers, Families, and friends to reconnect.

You have chosen a most noble profession. With your Families standing with you in support, you have borne the increased stress and burden of this war for our Army and our Nation. A grateful Army and Nation thank you.
