One unique aspect of this FEX is the multi-layered command and control that Aguayo is exercising. This three-tiered approach adds an additional layer of complexity to command and control and to communications up and down the chain, and it better resembles the way battalions operate when deployed to various locations throughout the world, according to Aguayo.

Because battalion personnel are comprised of various levels of experience, newer Seabees rely on the more experienced personnel for help. One of a number of Seabees who will be experiencing their first FEX is Builder Constructionman Amira A. Ramelize. "Being at the ECP (Entry Control Point) and making decisions has been the hardest part so far, but it's fun," said the Brooklyn, N.Y. native.

"We are performing very well," said Cmdr. Lore Aguayo, Commanding Officer of NMCB-11. "Our evaluators are providing a lot of great constructive criticism and input on how we can be better, and every single day I see us making those improvements. Even with the rain we've had
