The first event was a JIATF West Small Craft Maintenance Training (SCMTT) course provided to the Indonesian Marine Police in the city of Banka last February. JIATF West's SCMTT training in Bangka took place between the 18th of February and the 1st of March 2013 with the Indonesia Marine Police, referred to as "POLAIR", the acronym in Indonesian. ("Air" is the Indonesian word for water). The day before training, Director of POLAIR Banka, Grand Commissioner (O6 equivalent) Dede Ruhiat Djunaidi, invited members of the SCMTT to a meal complete with local durian fruit.

Training was attended by 22 members of POLAIR from various outstations in the Banka-Belitung district. The class overview during the first day of training included topics on electrical, internal combustion, hull corrosion and prevention, and planned maintenance. According to LCDR Stephen Bower, Officer in Charge for the SCMTT, the participants had an impressive work ethic. "The POLAIR demonstrated tremendous

aptitude toward learning and had an impressive work ethic. They asked pointed questions during lectures and worked tirelessly to complete tasks during the hands on training portion", said LT Bower.

Surabaya, each for one week. The three events bolstered the INP's ability to detect shipments of narcotics.

By the final event, a graduate of



the first iteration was able to apply the training and made a real world discovery of drugs hidden in a cargo container.

ast April, members of the U.S. Department of the Treasury's Internal Revenue Service coming from of the following PBOC departments: Financial Investigation, International Cooperation,

Criminal Investigation Division (IRS-CI), Department of Justice, and JIATF West travelled to Beijing, China for a first ever joint JIATF-W / IRS – CI training event with Chinese government officials. The training, a course in Financial



Investigative Techniques, was attended by twenty six participants from the People's Bank of China (PBOC), Ministry of Justice, and the Supreme People's Procuratorate with most of the attendees Attaché Wayne Chan. The team was made up of: Jennifer Schmidt, JIATF West; Neil Stambersky, International Training Team Manager and Instructor, IRS-CI; Wayne Chan,

Policy and Supervision on Money Laundering, Suspicious Transaction Report Analysis – Anti Money Laundering Bureau, and International Communication and Requests. The training event was kicked-off with opening remarks by IRC-CI Beijing

Counter Threat Finance Training Beijing China

IRS-CI Beijing Attaché; and Tom Murdock, Senior Instructor, IRS-CI.

The team also included IRS-CI Special Agent Darren Lian, a Mandarin speaker who has worked extensively on money laundering cases relating to China and Department of Justice Federal Prosecutor Ronald Cheng who had served as the Resident Legal Advisor to the U.S. Embassy Beijing (2005 – 2007).

Cheng is credited with working one of the first joint money laundering cases with the Chinese, the Bank of China Kaiping Subbranch, which resulted in the conviction of three individuals, one of whom, as a result of a plea bargain, gave up his rights to asylum and returned to China where he is currently serving a 12 year sentence.

The course was presented in English with simultaneous translation into Mandarin by two interpreters. Special Agent Lian and Federal Prosecutor Cheng delivered their lectures in Mandarin. During the week of training, two Chinese government officials provided lectures on money laundering legislation and bank records.

Zhang Xiao Ming, Director, General Counsel, Division of Legal Assistance in Criminal Matters from the Ministry of Justice provided an overview of the Mutual Legal Assistance Act that is currently in effect between the U.S. and China and Cao Zuoyi, from the Anti-Money Laundering Bureau of the PBOC provided an extensive overview of bank records used in China to include video and mobile phone numbers provided to the banks.

One highlight of the training was an extensive money laundering practical exercise. Participants were broken into teams and were told to come up with a scheme on how to launder a significant amount of cash out of China. A key concept repeated throughout the week of training was that oftentimes in order to catch a criminal, one has to think like a criminal. This exercise tends to highlight vulnerabilities of a countries' antimoney laundering regime and brings to light challenges often faced by law enforcement.

One theme among the various teams was corruption and the ease at which people are able to use underground banking systems to move money from China to Hong Kong and then offshore, oftentimes investing it in luxury goods that are hard to value (for example art).

Training was well received by the participants

and feedback from the students was positive. Feedback indicated great appreciation for the content, students were very impressed at how everything



tied together and instructors received several comments indicating this was the most substantive CTF training that they had attended to date.

JIATF West began planning for this training back in 2010. In 2011, RDML Tomney and a select staff traveled to China to lay the ground work for creating the training. In 2012, a needs assessment was conducted with the Beijing IRS Attaché and an IRS-CI Senior Instructor to begin to develop course material. With the success of this first CTF training, JIATF West is currently planning to conduct another course in Guangzhou, China's third largest city in June 2013. --

Over 20 members of the Maldives Police Service and the Maldives National Defense Force - Coast Guard were present for the opening ceremonies of JIATF West's training event at the Institute for Security and Law Enforcement Studies in Malé, Maldives.

A six member detachment from the JIATF West Small Craft Maintenance Training Team (SCMTT) provided instruction for three weeks on small craft maintenance and repair techniques, engineering theory, safe underway operation, and maritime law enforcement fundamentals.

"The U.S. has been assisting the Maldives in various domains of development... but their most significant assistance is in the development of our human capital," stated Chief Superintendent of Police Ali Shujai in his opening remarks. He went on to "highlight the importance of the Small Craft Maintenance Course because more than 90% of Maldivian territory is sea, and the participants will gain the required knowledge and skills to become more aware of safety, engineering, and marine maintenance."

United States Ambassador to Sri Lanka and Maldives Michele J. Sison noted, "These cooperative engagements boost rule of law and enhance Maldives' capability to provide law enforcement with the tools needed to combat drug trafficking and other crimes."

Adding compliant boarding techniques as part of the maritime law enforcement fundamentals taught by JIATF-W representatives also strengthens partner nation capabilities to safely conduct waterborne Visit, Board Search and Seizure events.

The closing ceremony for the event was attended by Brigadier General Abdulla Shamaal, MNDF commander of the Malé area and International Defense Cooperation liaison. General Shamaal offered his appreciation for the capacity building training his forces received, recognizing the importance of a strong maritime component given the geography and placement of the Maldives and the contemporary geopolitical climate of the region.

The Republic of Maldives is composed of a series of islands in the Indian Ocean with an estimated population of 390,000. According to the United

Nations Office of Drug Control, Maldives is not a drug producer, but serves as a destination for illicit drug smuggling.

Enhancing the capabilities of law enforcement to conduct waterborne operations helps to diminish the supply of illicit drugs entering the country and help secure Maldivian borders against external transnational threats. --

IATF West in cooperation with USEMB Phnom Penh and the U. S. Army's Joint Special Operations University conducted Counter Narcotics Training at the Khmer Government National Maritime Coordination Center (NMCC) in Sihanouk Ville, Cambodia from April 24th to May 3rd, 2013. Khmer Interagency Security Forces are developing skill sets in the areas of drug interdiction management and; operations, command, and control. The training is intended to enhance the Khmer Security Forces ability to assist in the fight against drug threats to Cambodia, the U.S. and their strategic partners.

The NMCC is a computer enhanced facility built by JIATF West in 2012. The ribbon cutting ceremony took place in September of 2012 and later became fully operational on the 8th of January 2013 after information technology installation portion of construction was completed.

This CNT event was the first training event to take place in the new NMCC facility. The training directly improves Cambodia's ability to counter the illegal transit of illicit drugs through its borders.

In addition to supporting counternarcotics efforts at the NMCC, JIATF West also plans to renovate the piers used by patrol boats that support the NMCC. Due to the current condition and age of the piers, the renovations will be crucial to facilitate future U. S. Navy port visits at the NMCC. --

Narcotics Enforcement Training Team The NETT - Thailand

The Narcotics Enforcement Training Team (NETT) is a new training program co-sponsored between JIATF West, DEA, and INL. The goal of NETT is to provide a whole of government approach to provide specialized and comprehensive training to law enforcement officials who directly work with investigating drug related crimes. The first NETT effort took place in Thailand with a Royal Thai Police (RTP) counter narcotic unit in May. If this new concept proves successful to all interagency partners, the NETT will be expanded regionally to include other agencies and countries.

Narcotics Enforcement Training Team The NETT - Thailand

Unlike previous counter narcotics training efforts where the audience is typically made up of officers from various units, the NETT provides training to an entire unit as a whole. With the NETT, investigative training also focuses on criminal enterprises. In addition to whole unit training and specialization, the NETT seeks to collect performance metrics related to both training and investigative effectiveness. With NETT, law enforcement officers are given pre and post training tests to help establish metrics. The DEA agents are not only instructors, but they are also mentors to the unit's receiving the specialized training. As part of the mentorship aspect of NETT, the DEA has plans to evaluate the progress of participants at three and six month intervals.

The curriculum provided by the NETT is very comprehensive with too many topics to mention in this article, however, some of the parent themes include a variety of intelligence analysis and data exploitation techniques, interdiction skill sets, operational planning, and law enforcement techniques such as arrest and control tactics.

The first ever NETT training event was a Narcotics Investigations Course presented by members of the Drug Enforcement Agency in Bangkok Thailand. Nineteen officers from a RTP sensitive investigative units participated in the class. DEA Special Agents Dave McConnel and Mark Gray were the main instructors. --

The 11th Executive Working Group (EWG) was held on the 24th of April 2013 at the Office of National Drug Control Policy conference room in Washington D. C. During the meeting, a framed letter from the ONDCP Deputy Director and United States Interdiction Coordinator, Ms. Marilyn A. Quagliotti, was presented to Mr. William Roig as a token of appreciation prior to his retirement as JIATF West's Deputy Director.

The letter cites Mr. Roig's tremendous personal dedication as the deputy director of JIATF West since July 2004, for his key role in the relocation of JIATF West from Alameda to Honolulu, and for transforming strategy to address evolving challenges in the Asia-Pacific region. "JIATF West has taken the lead and is blazing a new path to address the significant threat of trans-Pacifc trafficking of amphetamine-type stimulates and precursor chemicals (ATS/P)," said Ms. Quagliotti.

The very first EWG was convened by Admiral Zukunft on Wednesday, August 8, 2007 at JIATF West to establish routine outreach and strategic collaboration with a broad set

of law enforcement partners that have responsibility for addressing transnational criminal threats reasonably related to drugs in the US Pacific Command Area of Responsibility (AOR).

Responsibility (--Today, the JIATF West Executive Working Group strives to build and strengthen relationships among the interagency communities of interest dedicated to combating drug-related transnational organized crime (TOC) in the Asia-Pacific. Alignment and collaboration with the community of interest allows JIATF West to maximize its effectiveness in whole of government efforts.

> The EWG meetings are co-hosted between JIATF West, ONDCP and the Deputy Assistant Secretary of Defense for Counternarcotics and Global Threats.

Interagency partners attending include The Interdiction Committee (TIC), DEA, USCG, DOS/INL, ICE /HIS, IRS, CBP, DOJ, NCIS, DHS, FBI, and Treasury/OFAC.

CDR Dailey Organizes Local School Robotics Competition

JATF West Deputy Assistant Chief of Staff (ACOS) of Plans and Programs, CDR Bryan Dailey, USCG, helped the Coast Guard organize a robotics competition for local elementary school aged children. The U.S. Coast Guard and Navy have been working with Hawaii students for the past three years to promote interest in the science, technology, engineering, and mathematics (STEM) program. This year's robotics competition titled, "The Sea Perch Hawaii Challenge" took place on the 5th of May at the Coast Guard's Sand Island base. The event was attended by 120 5th to 8th students from 12 local schools.

Students used a controller tethered to the underwater robots to maneuver them through an underwater obstacle course. The robots were made by the students using a kits donated by DoD agencies and sent to interested schools by the Coast Guard. "This was a kit delivered in a box with nothing assembled. They had to waterproof the motor, wire the motor, assemble a circuit board and then solder in all of the pieces that go to the circuit board. They also had to figure out ballast, center of gravity, and thrust", said Dailey.

Each school team had six weeks to build their robots. Teams typically spent three weeks designing and planning, two weeks building, and one week testing their robots.

"We want to keep that good quality, smart, and educated person thinking about the Coast Guard," Dailey said.

Recipe of the Month by FSC Andrew Donahue, USCG



Risotto Cakes

This recipe comes from Cooks Illustrated and is one of Chief Food Service Specialist Donahue's favorites.

Ingredients

1/2 cup fresh bread crumbs (see illustrations below)

Pinch of salt

Pinch of ground black pepper

Small pinch of cayenne pepper (optional)

- 1 teaspoon minced fresh parsley leaves
- 1 large egg
- 1 cup leftover risotto, chilled
- 2 tablespoons finely diced mozzarella, fontina, or provolone cheese

1/2 – 2/3 cup vegetable oil for frying

Lemon wedges for garnish

Instructions

1. Mix the bread crumbs, salt, ground black pepper, cayenne pepper (if using), and parsley together in a small shallow dish. Beat the egg in another small shallow dish. Measure 1/2 cup chilled risotto and shape and fill it with 1 tablespoon cheese as directed in the illustrations below. Repeat with the remaining risotto and cheese to form a second cake. Dip each cake into the egg, allowing excess to drip back into the bowl. Dip both sides of the cake in the bread crumb mixture, pressing the crumbs with your fingers to form an even, cohesive coat.

2. Pour enough oil into an 8-inch nonstick skillet to reach a depth just under 1/2 inch. Turn the heat to medium-high and heat until the oil is shimmering but not smoking, about 2 ¬minutes. With a spatula, gently lower each cake into the pan and cook until golden brown, about 3 minutes. Flip the cakes with the ¬spatula and cook until browned on the other side, about 3 minutes. Transfer the cakes to a paper towel– lined plate, blot any excess oil, and serve immediately with lemon wedges.

Promotion to Chief Master Sergeant, USAF
