Bangladesh Base Development

A small team from JIATF West travelled to Bangladesh to conduct an Assessment in support of a law enforcement infrastructure improvement initiative. JIATF West, in cooperation with the US Embassy in Dhaka, hopes to bolster counternarcotics capabilities of both the Bangladesh Coast Guard (BCG) and the Border Guard Bangladesh (BGB) by funding much needed infrastructure projects that support training and Coast Guard maritime capabilities. The assessment, necessary to verify selection of FY14 projects, was led by Task Force Representative, LCDR Michael Hosey, USCG. Accompanying LCDR Hosey were Base Development Program Manager, Mr. Scott Hawman and Future Operations Officer, CW4 Andrew Siemens, USA.

The site visit took place between 27 October and 2 November 2013, and began in the capital city of Dhaka located on the east banks of the Buriganga River. In Dhaka, JIATF West team members met with US Embassy Country Team personnel as well as with the Director General of the BCG, Admiral K S. Hossian (equivalent to the US Coast Guard Commandant) and BGB Director General, Major General Aziz Ahmed. The Bangladesh Coast Guard, much like the US Coast Guard, has law enforcement authorities and patrols the waterways interdicting crime at sea. The BGB, on the other hand, is responsible for the security of land borders.

Bangladesh Base Development

After completing meetings in Dhaka, US Embassy Country Team members and a Bangladesh Coast Guard Officer accompanied JIATF West members to the Coast Guard base located in the city of Chittagong. During the visit, the team inspected base facilities and determined that the most beneficial project would be construction of a maintenance boat house to service the fast and technologically advanced patrol boats used by the Coast Guard.

After the base visit in Chittagong, JIATF West members traveled to Satkania, home of the BGB's National Training Center, where recruits, both enlisted and officer, live and train. JIATF West members received a warm welcome from base members who made a custom painted sign to welcome them. The National Training Center is the primary site for training and marksmanship for all Southeastern BGB members.

The BGB Director General, Major General Aziz Ahmed, identified top priorities as improvements to firing ranges as well as training in advanced marksmanship, drug detection capabilities and border management training.

Having conducted six training missions since first beginning to work with Bangladesh in 2004, JIATF West is no stranger to Bangladesh. However, the projects identified from this assessment will be the first ever funded by JIATF West in Bangladesh. Base Development Program Manager, Mr. Scott Hawman, who travelled to Bangladesh for the first

time, was very impressed with the cooperative nature of both the US Embassy and the Bangladesh military.

Equally impressive, according to Mr. Hawman, was the high level of English proficiency among the Bangladesh military officers. "Their excellent command of English allowed for ease of interaction and communication", said Mr. Hawman.

From the assessment, JIATF West will draft a mutually supported infrastructure concept of operations. The Law Enforcement Agency sponsor for projects is the International **Criminal Investigative Training** Assistance Program (ICITAP) and all projects will be implemented with the approval and coordination of the US Embassy's Office of Defense Cooperation (ODC). During 2014, Director of JIATF West, **RDML** James Rendon, USCG will personally travel to Bangladesh to sign documents that will allow for the implementation of the approved infrastructure projects. --

Counter Narcotics Training with Vietnam

uring 2013, two counternarcotics training events took place in Vietnam at the Police Training Center built by JIATF West. Both training events were funded by JIATF West in coordination with the Hanoi DEA office. The first training iteration was held in June and the second in September. Both were for eleven days. Each event had training provided by DEA Special Agents with Marine instructors in June and Army instructors in September. Capt Paul Trower, USMC was the JIATF West training liaison for both events. The training, titled, "Tactical Training Course 2013", was designed to improve field safety and law enforcement skills of Vietnam's specialized Counter Narcotics Police. In Vietnam, Counter Narcotics Police are part of the Ministry of Public Security and are known as the "C-47".

The June training took place between the 10th and the 21st and covered two main topics. The first week concentrated on the basics of field medicine and tactical combat casualty care, while the second week focused on law

enforcement techniques. Areas of law enforcement covered suspect apprehension, handcuffing, The September training was held from the 9th to the 20th and mirrored June's topics, but with an added area of specialty. A Representative of the Vietnamese Government specializing in Rule of Law gave

self defense, tactical safety, entry procedures, and operation planning. Three Marine and two Navy Corpsman provided the field medical training during the first week and three DEA Special Agents covered law enforcement. standards. Tactical combat casualty care was taught by six Army instructors from Fort Lewis, WA.

Both training sessions were a success and provided valuable instruction to 45 counternarcotics officers per session. --

Several iterations of JIATF West organized follow-on counternarcotics training were conducted in 2013 to support maritime security force units in the Philippines. This article covers the events of two of them. Iteration 5, which took place from 29 July to 23 August, 2013, and iteration 6, which took place 2-23 September, 2013.

Both training events were four weeks long, sponsored by the US Department of Justice International Criminal Investigation Training and Assistance Program (ICITAP), and were in support of Philippine National Police's Maritime Group – Small Boat Unit (PNP-SBU) located in Puerto Princesa,

on the island of Palawan. Classroom instruction took place in August at the JIATF West built Law Enforcement Training Center (LETC) and the SBU Headquarters. These same facilities were utilized in September. Organizing of the training was a collaborative effort between the Philippine National Police – Maritime Group (PNP-MG), ICITAP

JIATF West and the US Navy and Army instructors.

For the 5th iteration of training, 14 US Navy personnel and one ICITAP staff member trained 50 host nation police and military members. The student cadre consisted of 30 PNP-MG, five Philippine Coast Guard, five Navy, and 10 Marines. Topics included small boat handling and maintenance, electronic navigation, vessel boarding, rifle and pistol marksmanship, maritime defensive tactics, and first responder medical care. A multi-team culmination exercise

validate the efficacy of training. Special guests at the opening ceremony included Mayor of Puerto Princesa City, Hon. Lucilo Baryon and Deputy Director for Administration, PNP-MG, PSSUP Ferdinand Yuzon. For the closing ceremony, the Governor of Palawan, Hon. Jose Chavez Alvarez, was the guest speaker.

For the 6th iteration of training, 12 US Army instructors and one ICITAP staff member focused on unit-level tactics, emphasizing mission planning and developing procedures for joint operations. This event was specifically tailored for PNP-MG and PNP units from various neighboring provinces. Topics included warning and operations orders; advanced rifle and pistol marksmanship; cordon and search in a rural environment; and tactical first aid. The September training was also followed by a multi-team culmination exercise. Opening ceremony special guests included the Palawan Vice Governor, Hon. Dennis Socrates; Mayor Baryon; PSUPT Salibo; Director Maritime Group, PCSUPT Henry Losanes; and US Assistant Secretary of State for International Narcotics & Law Enforcement Affairs (INL), AMB William Brownfield who was the guest of honor and keynote speaker. IATF West Task Force U Representative to Oceania, LCDR Aja Kirksey, traveled to the island of stone money to attend the Federated States of Micronesia Joint **Committee Meeting** (JCM) in Colonia, Yap State in the Federated States of Micronesia on November 19, 2013. The JCM is an annual consultation between the FSM and the U.S. on issues of mutual interest under Title III of the **Compact of Free** Association relating to security and defense obligations.

Among other duties, Task **Force Representatives** participate in U.S. Embassy country team meetings and conferences to ensure synchronization of JIATF West activities with U.S. government partners. This meeting was an ideal Task Force Representative engagement opportunity, and will inform future engagements in Oceania to include facilitating a national biometrics database assessment with the FSM National Government, and potential engagement with the Micronesia **Transnational Crime Unit** in Pohnpei, FSM. Prior to the JCM, on the 17th of November, both delegations from the FSM

The order is awarded in five grades, Member (MNZM), Officer (ONZM),Companion (CNZM), Knight or Dame Companion (KNZM or DNZM); and Knight or Dame Grand Companion (GNZM).

For FY14 the IMS team will provide maritime law enforcement and small boat training to JIATF-West partner nation law enforcement agencies in Bangladesh, Philippines, and the Maldives. --

The curriculum focused primarily on boat maintenance, engineering, and safe underway operation, tailored to provide the most pertinent instruction to the majority of students with engineering or small boat related billets in their respective units. The course of instruction was comprised of both classroom and hands on practical training. Among many other topics, the lectures included anchoring, rigging, basic navigation, planned maintenance, operational logs, hull maintenance, internal combustion engine theory, and diesel injection theory.

Classroom training was followed by hands-on and practical instruction to help firmly establish the engineering and boat skills with the students. In addition to working on the platforms in the repair facility, the boats were launched and underway operational training took place on several of the RCN's rigid hull inflatable boats (RHIB). According to the IMS training team Officer in Charge, LCDR Stephen Bower, USN, previous training missions conducted by the former Small Craft Maintenance Training Team are showing results.

"The boat conditions upon arrival this year suggest that maintenance and repair techniques previously taught are still being implemented", said LCDR Bower.

JIATF West has a long standing and productive relationship with various Cambodian Military and Law Enforcement entities. Since 1996, JIATF West has organized 44 training events, to include two SCMTT missions and one IMS. JIATF West is looking forward to continued successes in counterdrug training efforts with Cambodia in 2014 with several planned training initiatives. --

Recipe of the Month - Seared Scallops with Herb-Butter Pan Sauce

This is a simple, fast, and romantic dish any novice can make. It's what I made for Valentine's day. Why go out and fight croweds when you can create your own magical dish at home? Add a couple of pieces of dark chocolate and red wine and it's a deal! And if the kids are home, better rent a movie from the Redbox for them!

Ingredients

For the scallops:

1 lb. dry large sea scallops
 1 Tbs. unsalted butter
 1 Tbs. extra-virgin olive oil
 Kosher salt and freshly ground black pepper

For the sauce:

3 Tbs. unsalted butter, cut into six pieces
2 Tbs. finely diced shallot (1 medium shallot)
1/4 cup dry white vermouth or dry white wine
1/4 cup finely chopped mixed fresh herbs, such as flat-leaf parsley and chives
1/4 tsp. finely grated lemon zest
Kosher salt and freshly ground black pepper
2 to 3 lemon wedges for serving

Cooking Tip: Be sure to have all your ingredients prepped for the sauce (shallots diced, herbs chopped) before you begin searing the scallops.

Directions:

Remove the tough abductor muscle from the side of each scallop (some scallops are sold with the muscle already removed). If you feel any grit on the scallops, rinse them under cold water. Pat the scallops dry with paper towels; surface moisture impedes browning. Heat a 10 or 12 inch nonstick skillet over mediumhigh heat for 1 to 2 minutes. Add the oil and butter, if using, and heat until quite hot.



Pat the scallops dry once more and put them in the pan in a single, uncrowded layer. Season with salt and pepper and let sear undisturbed until one side is browned and crisp, 2 to 4 minutes. Using tongs, turn the scallops and sear until the second side is well browned and the scallops are almost firm to the touch, 2 to 4 minutes. Take the pan off the heat, transfer the scallops to a plate, and set them in a warm spot. Let the pan cool for a minute before you make the sauce.

Return the pan to medium heat. Add a piece of the butter (1/2 Tbs.) and the shallots and sauté until the shallots begin to soften, about 1 minute. Add the vermouth or wine and simmer until reduced by about half, another 1 to 2 minutes. Add the herbs and lemon zest. Reduce the heat to low, add the remaining butter, and whisk constantly until the butter melts into the sauce. Return the scallops and any accumulated juices to the pan. Gently roll the scallops in the sauce to warm them through. Taste for salt and pepper and serve immediately with lemon wedges on the side to squeeze over the scallops.
