## Readiness exercise provides training, tests Airmen

Approximately 300 167th Airlift Wing Airmen deployed to the Alpena Combat Readiness Training Center, Alpena, Mich., as part of a readiness training exercise conducted May 3-10.

Dubbed Thunder Bay, the robust exercise tested the wing's ability to mobilize, operate and sustain its mission while operating in a contested environment.

"We don't do this for fun, we do this for preparedness," said Col. David Cochran, 167th AW commander. "We do this to stay ready to do the bidding of our nation."

Personnel representing functions across the wing participated in the event giving Airmen opportunities to train on processes they don't typically encounter during unit training assemblies at home station.

# New mobile app empowers 167th Airmen

167th Public Affairs Office

167th Airlift Wing Airmen have a new, mobile friendly way to find important base and career information.

Unit personnel can now access the 167th AW Sub App within the USAF Connect mobile app. Simply install USAF Connect from the Apple App Store or Google Play, select 167th Airlift Wing when prompted to add Favorites and swipe left from the USAF Connect home screen. Airmen can Favorite up to 10 organizations.

This full-featured app improves workforce engagement and efficiency by providing an array of robust features that enhance access to the information Airmen need to manage their Air Guard life and career. Top features include:

- Base Directory
- PFT Calculator
- Push notifications
- Private Groups
- Plane Talk

Airmen at the 167th AW are encouraged to download USAF Connect and add the unit Sub App to their Favorites. Additionally, when prompted, Airmen should allow the app access to the requested permissions; the app cannot be used to track you location and it collects no personal data.

"The USAF Connect app, along with our 167th sub app, provides Airmen with access to the information they need, whether it's specific to our wing or information from big Air Force," said Col. Cochran, 167th AW commander. "I encourage everyone to install this app, it will provide another means to communicate with each other; and this is the future of communication."

Cochran added he is especially excited about the Groups feature which will give our DSG's an easier way to stay connected with their shops throughout the month.

USAF Connect is an Air Force-wide mobile app designed to enable, engage and empower Airmen by centralizing and increasing access to the information they need for their careers. In addition to providing head-quarters-level information, local units can maintain Sub Apps, accessible through the USAF Connect Favorites Portal.

The 167th Sub App is maintained by the 167th Public Affairs Office. If you would like to add content or have suggestions to improve the app, please contact the Public Affairs Office at extention 5251.

Be sure to connect to the 167th AW Sub-App through the AF Connect App. The 167th AW standalone app will no longer be supported.



## 167AW Mobile App Groups feature

Groups is the easiest and fastest way to connect and instantly communicate with any group within our unit. It's easy and intuitive. Anyone can request to start a group. Any unit-affiliated function can have a group. You can belong to multiple groups. Members must use their .mil email adrress to request a group. Once they join, members will have access to important information such as messages, schedules, event details, photos, notifications, and more.

Groups is an informal, non-secure communication system not approved for classified, PII, FOUO or other sensitive information. Always consider OPSEC when posting to a Group. Groups are periodically montored for compliance.

## PRESERVING OUR HERITAGE

Tech. Sgt. Daniel Barrow and Tech Sgt. Daniel Baker use a pressure washer to remove decals from the F-86 Sabre Jet static aircraft displayed near the main gate at the 167th Airlift Wing, Apr. 30, 2019. The 167th's sheet metal shop will be replacing the faded decals with new decals and cleaning the aircraft's metal.

The F-86 is one of the first aircraft flown by the 167th which relocated to Martinsburg from Charleston, W.Va., in 1955. The unit flew P-51 Mustangs prior to operating the F-86. The unit moved to Martinsburg while converting from the P-51's to the F-86's. The F-86's required a longer runway than they had in Charleston at the time, spurring the unit's movement to the eastern panhandle of West Virgina. The 167th operated the F-86 for only a few years before a mission change brought C-119 Flying Boxcars to the unit in 1961.











Did you know the 167th Airlift Wing operated a fleet of eight C-121 Super Constellations for about 10 years, from 1963 to 1972?

These aircraft gave the unit, then called the 167th Military Airlift Squadron, worldwide capability. The 167th MAS often hauled cargo to support efforts in Vietnam.

Did you know one of the C-121's assigned to the 167th has been on display for about ten years at the Smithsonian National Air and Space Museum, Udvar Hazy Center in Chantilly, Va.?

Aircraft serial number 54-177 was once assigned to the regular U.S. Air Force then transferred to the Mississippi Air National Guard before coming to West Virginia. When the 167th transitioned to C-130 aircraft, 54-177 moved on to the Pennsylvania Air National Guard and eventually the Military Aircraft Storage and Disposition Center at Davis-Monthan Air Force Base, Ariz. In 1981 it was sold at an auction. The buyer intended to start a commercial air transportation company but when that venture fell through the aircraft made its way to the Smithsonian.

"After crossing many oceans, and visiting many countries of the world, after living at numerous bases, after surviving The Bone Yard, after being forced to live at the corner of an old field, one of the 167th Air Guard's former Connies is almost home in its new home," wrote the late Senior Master Sgt. Jimmie James after helping with the aircraft's restoration.

Several retired and current 167th AW members helped apply the West Virginia markings onto the aircraft prepping it for display at the museum.

## Air Force senior leaders update OCP uniform guidance

The Air Force announced April 23 new rules on Operational Camouflage Pattern uniforms that aim to better fit the needs of Airmen and the jobs they do while also holding fast to tradition.

The changes highlighted include authorization of the two-piece Flight Duty Uniform in garrison and updated patch guidance for the OCP uniform.

"During the initial rollout of the OCP, we originally matched our sister services regarding patch configurations as we sought to emphasize our role as a joint warfighting force," said Air Force Chief of Staff Gen. David L. Goldfein.

"In response to overwhelming feedback received from Airmen, we will make an easy 'sleeve swap' of the patch configuration to further elevate our focus on honoring the heritage of squadrons as the war-fighting units of the world's greatest Air Force. We will now place the squadron patch on the right sleeve along with the U.S. flag and move the higher headquarters patch to the left sleeve of the OCP."

Additionally, to provide commanders with expanded uniform options to fit myriad missions, on April 15, the two-piece flight suit, otherwise known as the 2PFDU, will be authorized to be worn in both garrison and deployed locations. The 2PFDU continues an effort to provide Airmen with improved form, fit and function to perform their duties in any environment.

The traditional flight duty uniform will also continue to be an option. Squadron commanders will now have the flexibility to make combat uniform decisions based on what is best for their Airmen to meet mission requirements.

"The new unit patch configuration of the OCP and 2PFDU also aligns with the traditional FDU, elevating the significance of squadron focus and identity, which supports CSAF's intent to revitalize squadrons," said Lt. Gen. Mark D. Kelly, Headquarters Air Force deputy chief of staff for Air Force operations.

In May 2018, Air Force leaders decided to transition to the OCP following feedback from Airmen that it is the best, battle-tested utility uniform available. It will also eliminate the need to maintain two separate uniforms – one for in-garrison and one for deployments.

The service expects to fully transition to OCPs by April 1, 2021.

# SAFE AND SECURE

## **Antiterrorism & Force Protection: Surveillance Operations**

These Antiterrorism/Force Protection tips address surveillance operations and actions to take if you suspect someone is conducting surveillance operations.

#### **DEFINITION**

- Continuous or periodic act of observing a person, a place, or a thing for the purpose of gathering information.

#### TYPES:

- Stationary
- Enroute Or Moving
- Technical Surveillance

#### INDICATORS:

- Illegally or suspiciously parked vehicles (e.g., along the installation perimeter or by high risk facilities)
  - Occupied parked vehicles
  - Personnel in unauthorized areas
- Personnel taking photographs, sketches or observing specific operations (air traffic, vehicle traffic, construction, etc.)

#### **ACTIONS:**

- Conceal your suspicions
- Do not force a confrontation
- Stop operations being observed
  - -- If possible and would not alert suspects
  - -- If operations are critical or sensitive, immediately stop actions
- Call the authorities (remember all details and make a report)
- Attempt to keep individuals under observation until authorities arrive

REMEMBER: Antiterrorism and Force Protection is EVERYONE'S job.

Any Air Force military or civilian member may file an IG complaint. However, many Department of the Air Force civilian complainants (e.g., discriminations, sexual harassment, and conditions of employment) must be addressed by agencies other than the IG. Anyone, including civilians with no affiliation, may file Fraud, Waste, and Abuse (FWA) disclosures. Depending on the circumstances, the IG may also accept complaints from dependents or relatives of active duty members and retirees and their dependents. It's always best for the actual "victim" or person who witnessed the alleged wrongdoing to file the complaint.

#### What type of complaints are appropriate?

Any FWA and violations of law, Air Force instructions, or policy should be reported through the appropriate grievance channels. The subject of your complaint must be an Air Force program or person. Bear in mind, however, the fact that you may disagree with your supervisor(s) over management styles or have what you believe is a "personality conflict" does not constitute an injustice or mismanagement. If you are not sure your concern is a reportable matter, contact your local IG office for guidance.

#### When are IG complaints appropriate?

Individuals should attempt to resolve FWA issues and personal complaints at the lowest possible level, using command channels before elevating them to the next higher level or to the IG. Further, complaints must be promptly filed within IG, command, or other grievance channels. IG's may dismiss a complaint if there is no FWA, recognizable wrong or violation of law, regulation, or policy. Also, complaints more than 60 days from date of occurrence will normally be dismissed, unless there are extraordinary circumstances or special Air Force interests to justify an investiga-

#### Where (I.E., with whom) should complaints be filed?

Complaints may be filed with a superior or commander in your chain of command, an IG or other appropriate inspector, or within any established grievance channel. FWA complaints may be reported to the Air Force Audit Agency (AFAA), Air Force Office of Special Investigations (AFOSI), security police, or other proper author. Promptly advise the AFOSI of suspected criminal misconduct or fraud. If you would like to file a compliant, please contact the local IG office. Complaints may be filed in person, by letter, via email or through a complaint hotline.
