

### HQMC SEMPER FIT SEEKS APPLICATIONS FOR THE 2022 ALL-MARINE RUNNING TEAM

Headquarters Marine Corps (HQMC) Semper Fit (MFS) is seeking applications from active duty/active reserve Marines interested in participating in the All-Marine Running Team.

The ALL-Marine Running Team is a men's and women's running team offering Marines the opportunity to represent the United States Marine Corps in competitions, including the Armed Forces Marathon Championships.

The minimum standards for applying are as follows:

#### Men

- 5k 17:00 Minutes
- 10k 35:00 Minutes
- 10M 58:00 Minutes
- Half 1:18 Hour: Minutes
- Marathon 2:48 Hour: Minutes

#### Women

- 5k 20:00 Minutes
- l0k 41:00 Minutes
- l0M 1:08 Hour: Minutes
- Half 1:32 Hour: Minutes
- Marathon 3:15 Hour: Minutes

Applicants are required to submit times from races competed in within the past year. The anticipated event in 2022 is the Armed Forces Marathon Championship (October 2022).

To be considered for participation applicant must include scores for the following All Marine Sports standard testing events, in addition to your sports experience/bio, in section VI of the application: Three Repetition Maximum (3RM) Deadlift, Bench Press and Squat; One Repetition Maximum (RM) Broad Jump and Pro-Agility; most current three mile and 880 yard running time. All applications must have a completed SECTION VIII-COMMAND ENDORSEMENT, to be considered. The application form can be found at https:(slash)(slash)usmcmccs.org/services/fitness/all-marine-sports/. Interested Marines must submit an application to participate directly to MFS no later than 10 April 2022. Please email completed applications to ombmccssportsapplications@usmc-mccs. org.

To participate, Marines are required to have a valid Government Travel Charge Card and an active Defense Travel System account. Funding for All-Marine Sports will be provided by HQMC.

# OSHA's on the way!

The Occupational Safety and Health Administration will be aboard Marine Corps Logistics Base Barstow May 16 to 20, 2022 to conduct a safety audit.

The safety audit is part of the OSHA process to evaluate the base for recertification compliance of the Voluntary Protection Program in order to recertify the base's Star Site status.

"MCLB Barstow achieved star status in 2008, with recertification approved in 2012 and again in 2017. If we are approved, this would be our 3rd recertification," said Sara Diaz, Safety and Occupational Health specialist. The entire base is in preparation for the OSHA visit. Directors need to prepare their departments. This entails taking a look at your departments and making sure they are up to the safety standards that the base has set. Base personnel are already required to engage in training percentages and program compliances. So, you are preparing for the audit by 'playing the game the way we practice."

Base Safety asks that when personnel are out and about, make sure the area is tidied up and make sure that people are aware of VPP audit dates.

"Conduct on the spot questions with your employees in order to ask them about VPP and if they are unaware of the program, then let's educate them," Diaz said.

The audit team will consist of two OSHA representatives, and some Special Government Employees to assist them with the audit process.

"A lot goes into an audit," Diaz explained. "Auditors will walk around our entire base's footprint, in order to take a look at functional areas and make sure that the base is providing a work place that is free from recognized hazards. During the walk-around, they will speak to the civilians and Marines, and ask about some of the tasks that each does in their respective positions. They will also ask them what they know about VPP.

They will also ask if the individuals know how to report a safety hazard or an accident. In addition, they may inquire about what type of Personal Protective Equipment is used and they may ask questions about particular jobs.

## Russian cybersecurity threats increasing – Become a Cyber Sentry

W ith new cyber threats targeting Americans, the Cyber Security Section aboard Marine Corps Logistics Base Barstow offers guidance to shore up security parameters for military personnel, civilians and families on base and at home.

"A cyber-attack may be defined as many things, but most commonly is referred to an attempt to breach computers and accounts to steal data," said Michelle Noice, Information System Security Officer, Cyber Security Section, S-6 Communications Department. "Thousands of attacks occur daily, ranging in types of attack vectors to include malware, phishing, vishing, ransomware, denial of service, cross-site scripting, SQL injection and more. It is our duty to be vigilant and protect our data."


An SQL injection, is a Structured Query Language injection, also known as SQLI, and is a common attack vector using malicious code for database manipulation to access information that was not intended to be displayed. The information may include any number of things, including sensitive data and customer details.

"The most current cyber threats are malicious cyber activities engaged by the Russian government," said Noice. "The Cybersecurity and Infrastructure Agency and other unclassified sources revealed that Russian threat actors are targeting industries and organizations within the United States and other Western nations. Their intentions are to suppress certain social and political activity, and to steal intellectual property, as well as to deter, disrupt, degrade, and deny U.S. military missions and operations."

Cyber-attacks frequently target users of social media and websites by using phishing attempts with emails and other messages that include malicious links or attachments.

"Nefarious actors may steal credentials, impersonate users with fake websites, and guess passwords by brute force," Noice explained.

#### **Top 10 Cyber Threats**



Security patches must be as strong as the rest of your cybersecurity protections

On March 21, 2022, the White House released a Statement by President Biden on our Nation's Cybersecurity, specifically regarding potential cyber-attacks by Russia.

President Biden stated: "From day one, my Administration has worked to strengthen our national cyber defenses, mandating extensive cybersecurity measures for the Federal Government and those critical infrastructure sectors where we have authority to do so, and creating innovative public-private partnerships and initiatives to enhance cybersecurity across all our critical infrastructure. Congress has partnered with us on these efforts — we appreciate that Members of Congress worked across the aisle to require companies to report cyber incidents to the United States Government."



"It is our duty as Active Duty and Federal Government employees to ensure consistent defense. All Marines, Civilians, and Contractors can make an impact at every level," said Dr. Michael Simko, Installation Information Technology officer.

One of the ways that the Marine Corps is addressing cybersecurity, is by encouraging Marines and their families, as well as civilians, to become Cyber Sentries.

"A Marine Cyber Sentry is responsible for protecting military networks and the country against cyber-attacks from enemy forces," Noice said. "Marine Force Cyber Commands provide guidance to the Marine Corps to create a cyber-minded culture to keep our organization battle-ready, agile, and more resilient due to the persistence of cyber threats. Cyber defense begins with the organization's cyber culture. Maintaining a defensive, in depth strategy on cyber hygiene and the command's cyber culture is imperative to reduce risk of cyber threats."

"Cyber-attacks are increasing every day," Simko said. "It is strongly recommended that all Marines, civilians, and contractors review their cybersecurity posture both at home and at work. This includes securing your home network, devices such as computers, laptops, tablets, Internet of Things, and mobile devices. When assessing your current cybersecurity posture, it is best to assess each device as it pertains to confidentiality, integrity, and availability. Confidentiality refers to the ability of the device to encrypt network traffic or data. Integrity refers to software and files not being altered. Availability refers the device being readily available for use and its intended purpose."

To harden your home network and devices:

• On your router – you must change the preset name and password. Choose the highest level of encryption available such as Wi-Fi Protected Access 2. Disable or set a different password for your guest network. WPA3 is an even better encryption solution available on some new routers. However, it is not yet compatible with all devices on a home network.

• Keep your software updated. Install and use anti-virus and anti-malware tools. Updating software does not include just Windows or Mac system updates. Be sure to update individual pieces of software also to the latest version, such

• Use strong passwords and challenge responses. Change the default password on devices. Try to aim for 12-16-character pass phrases, rather than a password if possible. Use a password wallet to securely store passwords. If you Google "strong password generator," there are tools available to create a strong randomized password with several options for selecting criteria.

• On your mobile device – use a Personal Identification Number, key lock code. Set autolock after none-use. Biometrics (facial scan and fingerprints) offer additional security on modern day smartphones.

Social Media, such as Facebook, Instagram, TikTok and Twitter, are other platforms that can be used to initiate cyber-attacks through phishing, fake social media accounts, and website links.

"Breached user accounts are the most common attack, in which a hacker steals a user's authentication credentials upon login, collects personal data, and uses the information to access other systems, steal identities, or scope out additional targets," Noice said.

The best protocols to secure your social media account are:

• Keep personal information private on social media. Restrict access to only family and friends.

"Per Maradmins 067/22, Defense Information Service Agency will provide anti-virus software for Marines, civilians and defense contractors with an approved .mil email address to use at home, free of charge," Simko said. "This subscription is good for one year at no cost and provide security for your home computer."

"You should know, when speaking to the audit team, to just be honest," Diaz said. "They will look at the entire Safety Program by looking at our training records, medical surveillance, PPE we have on hand, and they will check to ensure that we follow OSHA standards with our programs. They will also want to know if we have employee involvement in VPP."

The OSHA audit team will be checking to ensure that the command understands VPP and will want to ensure that base employees feel that they have a safe workplace.

"Everything we do, all of our programs and safety policies are in place," Diaz said. "Personnel just need to understand that the OSHA audit team will be here and that you may get asked questions. If you are following what's already in place then you are doing your part. If you see a hazard or something we need to address, report it. If we are prepared then we will not need to repair while they are here."

In order for the base to remain in the VPP program, OSHA evaluates the base and the Safety Programs every 3-5 years.

"This is our time to show that we are a safe installation and that we deserve to continue to be a VPP Star site," said Diaz. "Our hope is that we will be recertified for the 3rd time, making us the

first Marine Corps Installation to be recertified for a third time and we will have maintained this prestigious honor as a Star Site for over 14 years! I want everyone to understand that safety should always be on our minds, and our first priority. Our actions are what matters the most and that we continue to be safe so we can return home to our families and we can see our co-workers do the same. Safety is everyone's responsibility."
