## 167th Communications Flight redesignated as squadron

A ceremony marking the redesignation of the 167th Communications Flight as a squadron was held at Shepherd Field, Martinsburg, W.Va., Feb. 3, 2024.

During the ceremony the 167th Communications Squadron guidon was revealed and the 167th Communications Flight guidon was furled for the final time.

Air National Guard units nationwide are redesignating their communications flights to communications squadrons due to the growing responsibilities and emerging mission-sets required of the communications career field.

There's been many technological advances since the communications flight was established at the 167th nearly 60 years ago, explained Lt. Col. Donald Carpenter, 167th Communications Squadron commander.

"Now we're on the cusp of a new technological era with artificial intelligence, machine learning and large language models," said Carpenter. "A new season requires a new approach, and the Air Force sees that and is realigning the force to do that."

The 167th Communications Squadron units enables the information technology infrastructure of the wing. They are responsible for the computer and networking hardware, printers, cell phones, handheld tablets, software deployment, software updates, communications security for the classified network, radio equipment, wireless networks, base fiber optic and copper infrastructure that connects the wing to the Department of Defense network.

As a squadron, the communications unit is postured to take on additional roles to protect cyberspace platforms and to meet expeditionary and mission generation support requirements.

Carpenter acknowledged that there will be challenges as the squadron adjusts to the new mission-sets but said they will get through it.

"We've been on a journey for three years to reshape the organization to what it is today," he said. "We'll continue to drive that needle forward to much greater success."

Senior Airman Steven Heaton 167th CES

Senior Airman Steven Heaton is an Emergency Management Journeyman for the 167th Civil Engineering Squadron. He orchestrated emergency management training for 163 personnel, compiled materials for 27 building managers, conducted Disaster Response Force Training for 75 personnel and created auides for players and inspectors for the wina's readiness exercise. As the lead CBRN Defense Course Instructor, he facilitated 15 three-hour courses bringing the wing to a 98% training compliance rate. He served as the lead coordinator for the Wina's CBRN All-Hazard Management Response exercise and facilitated Disaster Response Force coordination during the exercise. Senior Airman Heaton also completed 36 credit hours towards his bachelor's degree in emergency and disaster preparedness.

Staff Sqt. Jordan Delinski is an Air Transportation Journeyman for the 167th Logistics Readiness Squadron. He led the Joint Inspection and loading of eight cargo increments, including 21.7 short tons of cargo and 529 kilograms of explosives, while coordinating the movement of 2 battalions in the 19th Special Forces Group. He facilitated the redeployment of the 104th Fighter Squadron as part of exercise Combat Hammer, conducting Joint and HAZMAT Inspections loading 24.8 short tons of cargo on two aircrafts, and similarly supported exercise Sunshine Rescue, inspecting and processing 56.18 short tons of cargo. Additionally, he served as the Joint Inspector for the 175th Wing during the large-scale, German led exercise Air Defender 23. Staff Sqt. Delinski sought further professional development, completing a first line supervisor course and an aerial port operations course.

He designed an open-source monthly intelligence brief on relevant world threats and priority intelligence requirements providing situational awareness of world events for command staff and unit members. He oversaw the analysis and development of 20 intel scenarios for the wing's Readiness Exercise and created numerous products to aid leadership's decision-making process during the exercise. As a representative of Autism Speaks. Master Sgt. Noel partnered with Virginia House of Delegates to develop and implement legislation to provide classroom security cameras to protect disabled children.


First Sergeant



# - BLACK HISTORY MONTH -

Black History Month is an annual observance originating in the United States, where it is also known as African-American History Month. Each year the Department of Defense (DoD), along with the rest of the Nation, recognizes the important contributions and rich culture of African Americans.

The Association for the Study of African American Life and History has chosen for the 2024 theme, "African Americans and the Arts."

Lt. James R. Europe brought African American music genres international while leading the 369th Infantry Regiment "Hell Fighters" band.

His Black musicians proudly played their own original music, including jazz, blues, ragtime, and patriotic tunes, amazing European audiences who were unable to replicate their unique sound. Lt. Europe and his band were celebrated as heroes upon their return at the war's end.

Europe was one of the first mainstream African American mu-

sicians. He is recognized as a composer, arranger, and American band leader and is credited as a major figure in transitioning ragtime into jazz and popularizing social dancing across the social class spectrum.

Leonora Hull Brown, a Women's Army Corps member during World War II, was crucial in creating the military's only all-Black female band.

Brown helped form the group after being denied participation in the all-White band. As the only one with musical experience, and with just 8 weeks until their first performance, Brown taught the women volunteers how to play instruments. Their first performance far exceeded expectations.

This group became recognized as the 404th Armed Service Forces band as it fought an uphill battle against discrimination and sexism. After several performances, they were defunded by the Army. However, through community activism, they were reinstated. Horace Pippin is one of the most celebrated African American painters of the 20th century and a veteran of World War I. Being self-taught, Pippin used a linear art style with powerful design and expressive color. Pippin enlisted in what would become the Army's 369th Infantry Regiment. During his service, a sniper shot permanently disabled his right arm.

Pippin wrote a vivid account of his wartime service and experiences in a 61-page journal which contains numerous battlefield illustrations detailing his injury and which inspired his later work.

The stories of incredible artists like Lt. James R. Europe, Leonora Hull Brown, and Horace Pippin exhibit just a few of the countless contributions to the arts made by African Americans. Their complex, trailblazing work has impacted the hearts and minds of millions of people.

During this special observance, the DoD honors the contributions made by African Americans in the arts and celebrates diversity, inclusion, and accessibility for all Americans.

# What are Unauthorized Disclosures?



### What are Unauthorized Disclosures (UDs)?

An Unauthorized Disclosure (UD) is the communication or physical transfer of classified national security information (CNSI) or controlled unclassified information (CUI) – including OPSEC Critical Information – to an unauthorized recipient.

### What are My Responsibilities as DOD Personnel?

**DoDM 5200.01 requires all DOD Personnel** to protect Critical Information and Indicators (CII). For example, the timing and location of deployment of wing medical personnel would be Critical Information, and the preparation of medical equipment for this deployment would be an Indicator.

### Why do DOD Personnel Have this Responsibility?

The unauthorized disclosure of CNSI, CUI, or CII can seriously damage America's national interests and needlessly jeopardize American lives. Not even a year ago a member of the Air National Guard was suspected of leaking highly classified military documents on social media. **OPSEC is everyone's responsibility.**  **Critical Information (CI)** is specific facts about friendly activities, intentions, capabilities, or limitations that an adversary seeks to gain an advantage. **Indicators** are detectable actions and patterns that can be interpreted and pieced together to reach conclusions or estimates concerning friendly intentions, capabilities, or activities.

For more information on DOD policies regarding Unauthorized Disclosures and your responsibilities, make sure to read through <u>DoD</u> <u>Manual 5200.01</u>, <u>Executive Order 13526</u>, and <u>Executive Order 13556</u>. Each of these will help clarify how to safeguard and declassify CNSI, how to identify and protect CUI, and how to safeguard critical information and indicators useful to adversaries.


Misinformation thrives on social media where anyone can share almost anything they choose, and attention spans are short. Here's a quick guide to help you understand what misinformation is and how to recognize it.

# Why do people share misinformation?

Many people share misinformation unknowingly and sometimes with good or altruistic intentions — whether to articulate their perspectives, warn others away from danger or join others in trying to make sense of the world around them.

But some research suggests that some people also knowingly share things they suspect are false — whether to damage "the other side" in a political debate, get social media likes and shares, or conform to their ideological identities.

Bad actors — such as hyperpartisans, trolls and even foreign agents — create and share disinformation to cause division and confusion, to promote political interests and points of view or for financial gain.

Watch out! While the emotions most often elicited by mis- and disinformation are fear, anger and outrage, more agreeable emotions like curiosity and hope are also used to bypass our cognitive defenses.

#### Misinformation: Information that is misleading, erroneous or false. Misinformation is generally shared – and

generally shared – and sometimes created – by people who are unaware that it's inaccurate. This is the best term to use when the intent of the creator or sharer is unknown.

### VERSUS

#### Disinformation:

A subset of misinformation that is deliberately created or shared with the intention to misinform and mislead others, usually to achieve a desired ideological, political or financial result.

#### Types

Adapted from First Draft's <u>seven types of mis-</u> and disinformation, created by Claire Wardle.

#### Misinformation can be categorized based on what makes it false or misleading. The following five types are commonly found online:

#### False context

An image, video, quote or other piece of content is presented in a new, false context that changes its meaning.

#### Fabricated content

Misinformation that is entirely made up, such as computer-generated imagery or entirely fictional reports presented as "news."

#### Stolen satire

A specific type of "false context" misinformation in which all or part of a piece of satire is presented as authentic.

#### Imposter content

Content — such as a fake tweet from a public figure, or a fake ad — that falsely uses a well-known name, brand or logo to fool people into believing that it is authentic.

#### Manipulated content

Photos, videos, graphics and other types of content that have been "doctored" in some way, such as having one or more elements artificially added or removed.



# Red flags WATCH OUT!

If you see these common misinformation themes and "rumor cues," proceed with caution:

#### Phrases

- "Let that sink in"
- "The media won't report this"
- "Make this go viral"
- "Do your own research" "There are no coincidences"
- I here are no coincidences

#### Patterns

- Manipulated text on signs or t-shirts
- Doctored "amazing" nature or space photos
- Photos of protests and crowds
- · Screenshots of articles with no links

#### Your best defenses

- 1. Checking out unfamiliar people and sources
- Glancing through social media comments for replies that call a post into question
- 3. A quick internet search using key terms from a questionable post

# Guidance on Political Activities for 167 AW Military Personnel, DSGs and AGRs

As we move toward the 2024 election season, all 167 AW military personnel must be aware of the limitations that affect their participation in political activity. While all personnel are encouraged to carry out the obligations of citizenship, they must be mindful of the longstanding tradition that the military organization remains apolitical. The primary guidance concerning political activity for military members is found in DoD Directive 1344.10, Political Activities by Members of the Armed Forces

Generally, you MAY, provided you are not in uniform and do not otherwise act in a manner that could reasonably give rise to the inference or appearance of official sponsorship, approval, or endorsement:

•Register, vote, and express a personal opinion on political candidates and issues, but not as a representative of the Armed Forces.

•Promote and encourage others to exercise their voting franchise, if such promotion does not constitute use of their official authority or influence to interfere with the outcome of any election.

•Join a partisan or nonpartisan political club and attend its meetings when not in uniform, subject to some restrictions (come talk to your JA team).

•Serve as an election official, if such service is not as a representative of a partisan political party, does not interfere with the performance of military duties, is performed when not in uniform.

Sign a petition for a specific legislative action or a petition to place a candidate's name on an official election ballot, if the signing does not obligate the member to engage in partisan political activity and is done as a private citizen and not as a representative of the Armed Forces.
Write a letter to the editor of a newspaper expressing the member's personal views on public issues or political candidates, if such action is not part of an organized letterwriting campaign or a solicitation of votes for or against a political party or partisan political cause or candidate. If the letter identifies the member as on active duty (or if the member is otherwise reasonably identifiable as a member of the Armed Forces), the letter should clearly state that the views expressed are those of the individual only and not those of the Department of Defense or the West Virginia National Guard.

•Make monetary contributions to a political organization, party, or committee favoring a particular candidate or slate of candidates, subject to the limitations (come talk to your JA team).

Display ONE political bumper sticker on the member's private vehicle.
Attend partisan and nonpartisan political fundraising activities, meetings, rallies, debates, conventions, or activities as a spectator when not in uniform and when no inference or appearance of official sponsorship, approval, or endorsement can reasonably be drawn.
Participate fully in the Federal Voting Assistance Program.

Generally, you COULD if you are not in uniform and do not otherwise act in a manner that could reasonably give rise to the inference or appearance of official sponsorship, approval, or endorsement; however, you must be aware of other restrictions in law:

•Participate in partisan political fundraising activities, rallies, conventions (including making speeches in the course thereof), management of campaigns, or debates, either on one's own behalf or on that of another, without respect to uniform or inference or appearance of official sponsorship, approval, or endorsement. Participation includes more than mere attendance as a spectator.

•Use official authority or influence to interfere with an election, affect the course or outcome of an election, solicit votes for a particular candidate or issue, or require or solicit political contributions from others.

•Allow or cause to be published partisan political articles, letters, or endorsements signed or written by the member that solicits votes for or against a partisan political party, candidate, or cause. This is distinguished from a letter to the editor as permitted above.

•Serve in any official capacity with or be listed as a sponsor of a partisan political club.

•Speak before a partisan political gathering, including any gathering that promotes a partisan political party, candidate, or cause.

•Participate in any radio, television, or other program or group discussion as an advocate for or against a partisan political party, candidate, or cause.

•Conduct a political opinion survey under the auspices of a partisan political club or group or distribute partisan political literature.

•Perform clerical or other duties for a partisan political committee or candidate during a campaign, on an election day, or after an election day during the process of closing out a campaign.

•Solicit or otherwise engage in fundraising activities in Federal offices or facilities, including military reservations, for any political cause or candidate.

•March or ride in a partisan political parade.

Display a large political sign, banner, or poster (as distinguished from a bumper sticker) on a private vehicle.
Participate in any organized effort to provide voters with transportation to the polls if the effort is organized by or associated with a partisan political party, cause, or candidate.

Sell tickets for or otherwise actively promote partisan political dinners and similar fundraising events.
Attend partisan political events as an official representative of the Armed Forces, except as a member of a joint Armed Forces color guard at the opening ceremonies of the national conventions of the Republican, Democratic, or other political parties recognized by the Federal Elections Committee or as otherwise authorized by the Secretary concerned.

•Make a campaign contribution to, or receive or solicit (on one's own behalf) a campaign contribution from, any other member of the Armed Forces.

•Commissioned officers shall not use contemptuous words as prohibited by Article 88 of the Uniform Code of Military Justice or participate in activities proscribed in DoD Directive 5200.2, Personnel Security Program, and DoD Directive 1325.06, Handling Protest, Extremist, and Criminal Gang Activities Among Members of the Armed Forces.

# SAFE AND SECURE

### Antiterrorism & Force Protection - Travel Security

These tips address travel security.

One time when complacency can get us in trouble is when we travel. Here are a few tips that will increase your security the next time you go TDY, leave, or PCS to an OCONUS location.

- Avoid using military style bags such as A-3, B-4 or duffel bags, unless traveling Military Air.
- Remove all military logos, patches and stickers from your luggage.
- Ensure your luggage tag doesn't show your rank or military address.

- Travel in conservative civilian clothing when using commercial transportation or when traveling military airlift if you are connecting with a flight at a commercial terminal in a high risk area.

- Don't wear distinct military items such as organizational shirts, caps or issued shoes or glasses.
- Wear a long sleeved shirt if you have a visible U.S. affiliated tattoo.
- Remember to be aware of your surroundings, be suspicious and don't become the target.
- Do not use rank or duty title when registering in a hotel (if possible)
- If staying in same hotel for extended period of time, try to change rooms
- Try to get a room on the 2nd to 6th floors
- Ensure room is locked and valuables are secured (e.g., safe, take them with you)

We also provide on-target and on-time legal advice and assistance to military members, retirees and their family members. Legal assistance is provided in a wide range of areas including:



You may contact the West Virginia Area Defense Counsel (ADC) if you think you need legal representation because you are subject to a command investigation, adverse administrative action, or non-judicial punishment under the West Virginia State Code. Your ADC has offices at the 167th Airlift Wing in Martinsburg, WV and at the 130th Airlift Wing in Charleston, WV.

The ADC provides members of the West Virginia Air National Guard (130th and 167th AW) with legal representation when facing potential adverse or administrative actions. Your ADC is an experienced Judge Advocate located outside of your local chain of command, which prevents any appearance of, or possible command influence or conflicts of interest. This allows Airmen of the WVANG to receive completely confidential representation and assistance.

You may need to contact your ADC if you are facing any action against you such as:

- WV Non Judicial Punishment
- Administrative discharge and Demotion actions
- Denial of Reenlistment
- Referral EPRs/OPBs
- Suspect Rights Advisements
- LOCs, LOAs, and LORs
- UIF entries and control rosters
- Any other adverse actions in which counsel for an individual is required or authorized

The ADC is not able to assist in certain areas such as personal civil legal matters and congressional complaints. However, if you have any questions as to the availability of our services, please email to make an appointment.

The Area Defense Counsel is available for WVANG members only. Sister services must contact the nearest servicing base for representation.

# **STOP** Human Trafficking

Force, fraud, or coercion to compel a person to provide labor, services, or commercial sex.

Victims come from all backgrounds and can be women, men, and children.

Any minor (under 18 years of age) involved in commercial sex is a victim of human trafficking.

# **Recognize SIGNS**

Physical/Environmental Indicators include signs of abuse, no identification, confined to worksite.

Psychological/Behavioral Indicators include submissive, anxious, lack of free will.


