## ANA 201st Corps Hold Second Election Security Conference

ANA Maj. Gen. Mohammad Raheem, 201st Corps commander, discussed security issues for election sites with organizations including; National Directorate of Security, Afghan National Police and Afghan National Army.

The 201st Corps has been working in conjunction with Afghan Security Forces and International Security Assistance Forces to ensure safe and peaceful parliamentary elections in eastern Afghanistan on Sept. 18.

The upcoming elections are a crucial test in the security that the Afghan National Army can provide.

They 201st Corps is responsible for eleven provinces. These provinces contain both highly populated cities and rural villages that are spread out and almost isolated. The challenge is to ensure the safety of all the voters from insurgent forces.

U.S. Army Maj. Gen. John F. Campbell, 101st Division commander, evaluated the security forces' courses of action for the parliamentary election within the 201st Corps area of responsibility.

Maj. Gen. Abdul Nasier Zeiyai, OCCR commander, presented sensible plans for his area of operations and briefed about changes.

Maj. Gen. Abdul Haleem Khohistani, Afghan National Police commander for the 202nd Shamshad Zone, and different staff sections of 201st participated at the meeting.

Wardak classified the joint operational security planning meeting of election sites, and requested additional support and guidance of MoD Chief of Staff.
