Responsibilities of a Legal Advisor

My name is Col. Ahsanullah Poupalzail. I am the Judge Advocate for the 201st Corps.

As a legal advisor I am the representative of the legal department of the Ministry of Defense and the legal advisor of the 201st Corps commander.

I give guidance on issues pertaining to the rule of law in the country. I concentrate specifically on the Afghan National Army regulations, policy and military training.

I am the conductor of military policies, military training, and an advisor for solving problems that don't require a court trial.

Part of my responsibilities include making the personnel aware of the constitution of Afghanistan.

The responsibilities of the Judge Advocate are to be an advisor for the 201st Corps commander and unit commanders, in legal cases. The legal advisor works directly for the Corps commander.

The main task of the legal advisor is to give legal guidance to prevent crime at the unit, and instill military discipline, according to the Government of the Islamic Republic of Afghanistan.

In the ANA we have judicial, executive, and summary court marshal. The legal department is a professional department for the conducting of discipline, crime prevention and a good cooperator of the Corps commander.

The legal department has the main task of increasing the combat preparedness, unit discipline, the proper execution of military order,



and to regard international legal guidance while conducting military tasks.

The legal department has the responsibility to hold all personnel to the same legal standards.

The legal advisor must have good coordination with the commanders of the units so that they are able to investigate the military cases under arduous circumstances.

We try to eradicate the crime at the units. So, it is required that we should train the legal staff to execute their tasks at the unit.

It is the responsibility of the legal department to give guidance to the ANA about the Afghanistan constitution, decrees, and crimes at their unit level. Therefore, they can regard discipline in their unit in order to have a good, cohesive military unit.

The legal department has a responsibility to provide professional legal courses for the combat-preparedness of the personnel. Also, we give guidance about legal issues to the commanders of the units.

The legal officer has the task of investigating criminal cases and reporting to the prosecutor for daily follow-up, so the prosecutor can solve their problem with the support of the investigation department.

For solving problems at the units without court intervention, we are giving legal guidance to the commanders.

Another responsibility of the legal department is decreasing crime and breakdown of military discipline. We do this by explaining Article 17, item three and article 18 of the Military Judicial Law to the commanders in order to start their essential investigations.

A final responsibility of the legal department is to give legal guidance to the commanders of the unit about Soldiers who are Absent Without Leave.

3rd BDE units participated in the professional training.


Fareed Shah taught the communication class. The students received their certificates from Shah July 26.
