







The DAMOS team completed four surveys over the past season to collect seafloor dwelling worms and clams. Animals were collected during offshore surveys at the Cape Cod Bay, Massachusetts Bay, Rhode Island Sound, and Western Long Island Sound Disposal Sites by using a large clam rake towed

off the back of a research vessel.

DAMOS scientists then carefully sorted through the mud brought up from the depths of the seafloor to select the target species. Tissue samples from these animals will be analyzed for a suite of compounds to aid in the management of the sites and to inform decisions about dredged material proposed for offshore disposal from harbors throughout New England.







## Regulatory Division holds Public Meeting in Vermont

The New England District's Regulatory Team held a joint public outreach meeting with the Environmental Protection Agency and the Vermont Agency of Natural Resources (VT ANR), March 27 at the Capital City Grange in Berlin, Vermont. About 20 people attended in person and 169 chose to join virtually. The event was held to inform interested parties of updates in the regulations and the policy related to VT ANR and the Department of the Army permit evaluation processes.

Elizabeth Gosselin, New England District's Chief of Public Affairs, moderated the event. She welcomed both the in person and virtual audience and introduced the speakers.

Laura LaPierre, Program Manager, Wetlands Program and Misha Cetner, Lake and Shoreland Ecologist, Lakes and Ponds Program, both with the VT ANR, discussed state permitting and jurisdiction, the wetlands program, the lakes and ponds program and the River program.

Rachel Croy, Life Scientist, Wetlands Protection, from EPA Region 1, spoke about updated to federal rules to include changes to water of the United States and the 2023 Clean Water Act Section 401 water quality certification improvement rule.

After a break, the New England District's Regulatory team stepped to the podium to make their presentations. Tammy Turley, Chief of Regulatory led the team by presenting the Program Overview and Authorities and the Vermont General Permits. During her presentation, she urged many times for the public to give her team input.

Angela Repella, Project Manager for New Hampshire and Vermont, talked about the Regulatory Authorities that affect the state of Vermont – Section 10 of the Rivers and Harbors Act and Section 404 of the Clean Water Act

Frank Delgiudice, New Hampshire and Vermont Section Chief, rounded out the speakers with his presentation on Regulatory Division's Regulatory Request System.


