# NOTICE REGARDING MODIFICATION OF CULTURAL ACCESS AGREEMENT PARAGRAPH\_8C

PLEASE TAKE NOTICE THAT, Pursuant to paragraph 13 of the Settlement Agreement and Stipulated Order in Malama Makua v. Rumsfeld, et al., Civ. No. 00-00813 SOM LEK (D. Haw. Oct. 4, 2001) ("2001 Settlement"), Malama Makua, the Secretary of Defense, now Robert Gates, and the Secretary of the Army, now Pete Geren, (collectively "the Parties"), established the protocols for cultural access to Makua Military Reservation

("MMR"), which were set forth in the document entitled "Appendix

B, Daytime and Overnight Access to Makua Military Reservation for

Cultural Access" (filed July 19, 2002). Paragraph 9 of Appendix

B authorizes the modification of the cultural access protocols by

mutual consent of the parties.

The Parties mutually consent that Appendix B, Section 8

("Activities While Present on Makua Military Reservation"),

Subsection C ("Limitations on Activities"), Item 8 be modified as sent forth in "First Modification to Appendix B, Daytime and

Overnight Access to Makua Military Reservation ('MMR") for

Cultural Access" attached hereto as Exhibit "1"

The terms of this modification have been negotiated at arm's length among knowledgeable parties represented by experienced counsel. As a result, the rule of "interpretation against draftsman" shall not apply in any dispute over interpretation of the terms of this modification. Should any court with jurisdiction to enforce the 2001 Settlement declare or determine that this modification is illegal or invalid, the validity of the remaining parts, terms, or provisions of Appendix B shall not be affected thereby and said modification shall be deemed not a part of Appendix B.

This modification shall apply to and be binding upon the Parties, their members, delegates, and assigns. The undersigned representatives certify that they are authorized by the Party or

Parties that they represent to enter into this modification of Appendix B, and to execute and legally bind that Party or Parties to the terms and conditions of this modification.

First Modification to Appendix B, Daytime and Overnight Access to Makua Military Reservation ("MMR") for Cultural Access

The Parties mutually consent that Appendix B, Section 8 ("Activities While Present on Makua Military Reservation"), Subsection C ("Limitations on Activities"), Item 8 be modified as follows:

- "8. For safety reasons, covered shoes are required while on MMR, except in the following areas where the wearing of shoes is optional:
  - "a. In the paved and cut grass areas around Range Control and the Range Control Tower (depicted in green on Enclosure "A" hereto);
  - "b. In the cut grass areas (i) mauka of Range Control bisected by the centerline road and bounded by the drainage area to the north and by the north firebreak road to the east and by the centerline road to the south; (ii) approximately 10m (33 feet) around the Makua ahu; (iii) at the south firebreak/centerline road junction; and (iv) to the south of the centerline road and leading to the petroglyph rock at site 5926 (limits depicted in yellow on Enclosure "A" hereto);
  - "c. To access the petroglyph, well and/or spring features of site 5926 (limits depicted in blue on Enclosure "A" hereto);
  - "d. On the north firebreak road, south firebreak road, and centerline road, outside the known improved conventional munitions area (depicted in red on Enclosure "B" hereto); and
  - "e. To access the ahu at Kahanahaiki and Ko'iahi (limits depicted in yellow on Enclosure "C" hereto).

"Activities permitted without shoes in the areas described in subparagraphs 8.a through 8.e include, but are not limited to: celebrating Makahiki; offering ho'okupu; offering oli; dancing hula; conducting an 'awa ceremony; and entering spring/well features to clean, collect water, and/or offer ho'okupu."






