SUBJECT: Command Policy Memorandum Number 18, Facial Hair Inspection Card

1. Reference: Army Directive 2025-13 (Facial Hair Grooming Standards), 7 July 2025.
2. Purpose: Establish policy for a facial hair inspection card for the 66th Military Intelligence Brigade (Theater).
3. Applicability: Applies to all service members assigned or attached to 66th MIB-T.
4. Soldiers with an approved exception to policy (ETP) for facial hair grooming standards or religious accommodation will carry their facial hair inspection card in lieu of their ETP or accommodation. Soldiers must, upon request, readily produce a legible version of this card when in uniform or on duty in civilian clothes. Inspection cards must be digitally signed.
5. Questions regarding the Soldier's ETP, accommodation, or compliance with the Army standard will be directed to their company or battalion chain of command. Questions regarding this policy will be directed at the brigade command team.
6. Period: Until officially rescinded.
