GTCC FOR PCS

All eligible Sailors are required to use the GTCC during PCS.

Advances are not authorized with the GTCC except for family non-concurrent travel, and PPMs.

Sailors will still receive DLA, which is an entitlement.

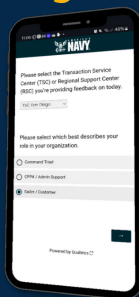
RETIREE ID CARDS

Retirees are encouraged to upgrade to the Next Generation Uniformed Services ID (USID).

DOD has not yet announced when legacy (Teslin) USIDs will no longer be accepted.

GOVERNMENT SHUTDOWN

How the lapse in appropriations is affecting Sailor Pay

MyNavy Career Center's top priority is paying Sailors accurately and on time.

The government shutdown will result in delays to pay and entitlement updates.

We know customers may be concerned, and we are closely monitoring transaction timelines and aligning our team's resources appropriately to prioritize paying Sailors and executing PCS travel.

HERE'S HOW THE GOVERNMENT SHUTDOWN IMPACTS SAILORS

Background

About 50 percent of MNCC's pay processors and auditors are on furlough.

MNCC processes, audits, and submits pay transactions to DFAS for release.

DFAS cannot release payment during the government shutdown.

PCS Travel

If you received orders already, don't worry, your travel is funded.

If you are in training (I-stop), MNCC and NPC are working together to get you on your way.

Call MNCC at (833) 330-6622, Option 2 for NAVPTO.

GTCC Usage

You can still use your GTCC to cover authorized PCS expenses.

Your GTCC stays active during the shutdown. Remember: You must ensure you pay it off.

If you need to extend your Mission Critical status, call MNCC anytime.

Reenlistments

Selective reenlistment bonuses will be delayed.

If you can, wait to reenlist until the end of the month.

If not, reenlist now to maintain career continuity but expect a delay in receiving your SRB.

Separations

Final pay for separating Sailors may be delayed.

Orders effective on or before Sept. 30, 2025, should not be affected.

Short-notice separations (e.g., PDRL/TDRL, ADSEP, Reserve deactivation) may see final pay delays.
